The Commercial exhibits will be open Thursday through Sunday. And for a third year, if your booth is still set up at the close of the commercial building, early Sunday evening, you will have a chance to win your booth entry fee back - or even more! So don't leave too soon and miss out on this opportunity. Do to a great deal of early interest in the commercial spaces this year we recommend early reservation of you booth space to guarantee your spot. **Please Note:** Exhibitor must comply with a Minnesota Department of Revenue "Sales Tax Fact Sheet 148" and must complete and return sales and use form ST-19 whether or not exhibitor intends to sell products or services at the Big Stone County Fair. No exhibitor or concessionaire will be allowed to set up without having the ST-19 form on file in the fair office.
